P19/1924/F: 83 Bath Road, Bridgeyate – Erection of a single storey side and rear

extension to form additional living accommodation. Installation of rear dormer.

The comments of the Parish Council are No Objection.

P19/1944/F: Alverstoke, Keynsham Road, Willsbridge – Demolition of existing

conservatory. Erection of single storey side and front extension and two storey and single storey rear extensions to form additional living

accommodation. Alterations to outbuilding to form garage,

workshop and plant room.

The comments of the Parish Council are No Objection.

P19/2155/TCA:

84 Bath Road, Bitton – Works to fell 1 no. Beech Tree (T2) situated in the Conservation Area.

The comments of the Parish Council are No Objection subject to the views of the South Gloucestershire Tree Officer. However, we would like to stress that the application is just for 1 No. Beech Tree and not 2.

P19/2131/F:

13 Westcourt Drive, Oldland Common. Erection of 1 no. semi detached dwelling with associated works (resubmission of PK18/5748/F)

The comments of the Parish Council are Objection. The Council feel that this is a complete overdevelopment of the site with a loss of the front garden, loss of green space and is detrimental to the street scene and area.

P19/2213/F:

91 Cloverlea Road, Oldland Common. Erection of single storey rear extension to provide additional living accommodation.

The comments of the Parish Council are No Objection.

P19/2416/F:

12 Nicholettes, North Common. Erection of front porch and canopy to provide additional living accommodation.

The comments of the Parish Council are No Objection.

P18/6741/R3F:

Willsbridge Mill – Creation of 20 No car park spaces with access, landscaping and associated works

The comments of Bitton Parish Council are Objection. The Council feel that as this is in an area of natural beauty and within greenbelt they want this area kept natural and the creation of the car park would ruin the environment and the wildlife habitat. The creation of car parking spaces will take away the greenery and will go against the whole ethos of Willsbridge Mill. The council are also concerned about the exit and entrance coming out on what is already a very

busy road.
