A member of the public raised concerns over planning application P21/07719/F. Concerns are raised over the accuracy of the application and how many businesses are actually running from this location. The member of the public felt that the daily noise nuisance and treatment of the animals that are being looked after needed to be looked into together with the correct disposal of collected faeces. Concerns were raised over the amount of horse riders within the area and the amount of times the animals run up to the fencing and bark at them passing that this could cause an accident.

Land at the Willows, Upton Cheyney. Change of use of land from agricultural to equestrian and dog care (sui generis) as defined in the Town and Country Planning (use classes) Order 1987 (as amended), and erection of 1 no wooden field shelter (Retrospective)

Bitton Parish Council strongly Object to this planning application. The application site is within the Cotswold Area of Outstanding Natural Beauty and the proposed use of land for dogs is unsuitable. The site is adjacent to a sharp bend on a narrow lane and the application will generate additional traffic creating a highway hazard.
